June is always an exciting time of the year! We say with pride "farewell" to all graduating residents and welcome the new ones.

54 residents are graduating successfully from the WSU GME programs. They will be going to fellowships, entering academic careers and joining private practices. Many of the graduates are staying in Michigan.

We were very successful in the 2014 Residency Match program, matching 100% of all 51 slots in our programs of which 30 were U.S. graduates, including 13 who are graduating from WSU School of Medicine. The candidate pool was very impressive and the recruitment effort ended with an outstanding result.

We are all aware that as of July 1, 2014, all programs are entering the ACGME NAS (Next Accreditation System). We have been revising all GME policies to reflect that change. The GMEC is working diligently to provide appropriate guidance and oversight to all programs to accomplish this transition smoothly.

The main focus for the next academic year will be adaption to the NAS requirements and implementing institution-wide projects on the six CLER focus areas:

Patient Safety Quality Improvement Transitions in Care Supervision Duty Hours Oversight, Fatigue Management and Mitigation Professionalism

We will also be looking into utilizing new evaluation tools for residency and program outcomes.

Karmanos Cancer Center with WSU Use Google Glass in Pilot Study

Released through PR Newswire In Detroit on May 7, 2014, doctors with the Head and Neck Oncology Multidisciplinary Team at the Barbara Ann Karmanos Cancer Center announced an ongoing partnership with Wayne State University to study using Google Glass to enhance communication following a patient's surgery.

Google Glass is a hands-free, eyewear device that facilitates communication and interaction within the wearer's surroundings. The device combines a computerized central processing unit with a display screen, touchpad, high-definition camera and wireless connectivity. Google Glass is fully controlled by a combination of voice commands, head tilts and touch.

The study will involve using two Google Glass devices in surgery where transplanted tissue must be monitored continuously to ensure good patient outcomes, as well as for other areas of patient care. Karmanos is among the first medical centers in the world to use Google Glass to disseminate patient information among medical staff.

"We plan on utilizing Google Glass to transmit and record the status of the flap between resident physicians and their supervising physicians," said Sagar Patel, M.D., resident with the Head and Neck Oncology Multidisciplinary Team at Karmanos. They plan to publish their findings in medical literature.



Single Accreditation System for US Graduate Medical Education Programs

Announced February 26, 2014 -

The Accreditation Council for Graduate Medical Education (ACGME), the American Osteopathic Association (AOA), and the American Association of Colleges of Osteopathic Medicine (AACOM) have agreed to a single accreditation system for graduate medical education (GME) programs in the U.S.

The single accreditation system will allow graduates of allopathic and osteopathic medical schools to complete their residency and/or fellowship education in ACGME-accredited programs and demonstrate achievement of common Milestones and competencies. Currently, the ACGME and AOA maintain separate accreditation systems for allopathic and osteopathic educational programs

Operational details are in the process of being defined. It is obvious that there are significant details of processes and timelines that must be formalized in order to promote the smooth and orderly implementation of this agreement

Planning meetings have been scheduled, and the ACGME will continue to provide more information as subsequent steps are defined. The ACGME web site will provide updates as they occur.

Administrative Updates

PC DEVELOPMENT

- At the last PC meeting we discussed the use of the Portfolio review in New Innovations. Using this feature for the Semi-Annual evaluations of the residents would eliminate the need to print out individual evaluation forms. We hope that all programs will adopt this time (and paper) saving way to produce the evaluation forms.
- The GME office has put together a shared calendar with all of the important dates that the programs need to be aware of – all PCs have access to the calendar and can add their program's special events.
- SharePoint is a Microsoft product that is used for collaboration. We started using it with the QI team at Crittenton Hospital Medical Center and will be expanding its use throughout all of the programs. It is a secure site and is HIPAA compliant.

NEW INNOVATIONS

 New Innovations is working on the Annual Program Evaluation process. They may have it established by next year. They are also working on a process to gather all of the data needed for the Annual Institutional Review.

INTERNAL REVIEWS

 Internal Reviews are being replaced by other program reviews. The GMEC will decide what criteria will be evaluated to determine which programs will need to undergo a special review.
