<u>From Your DIO</u> Tsveti Markova, MD, FAAFP

The 2014 **CLER** (Clinical Learning Environment **R**eview) visit took place at Crittenton Hospital on Sept. 23 & 24, 2014 The CLER assesses sponsoring institutions in the following six focus areas: **Patient Safety**—including opportunities for residents to report errors, unsafe conditions, and near misses, and to participate in inter-professional teams to promote and enhance safe care.

Quality Improvement—including how sponsoring institutions engage residents in the use of data to improve systems of care, reduce health care disparities and improve patient outcomes.

Transitions in Care –including how sponsoring institutions demonstrate effective standardization and oversight of transitions of care.

Supervision—including how sponsoring institutions maintain and oversee policies of supervision concordant with ACGME requirements in an environment at both the institutional and program level that assures the absence of retribution.

Duty Hours Oversight, Fatigue Management and Mitigation—including how sponsoring institutions: (i) demonstrate effective and meaningful oversight of duty hours across all residency programs institution-wide (ii) design systems and provide settings that facilitate fatigue management and mitigation; and (iii) provide effective education of faculty members and residents in sleep, fatigue recognition, and fatigue recognition and fatigue mitigation. **Professionalism**—with regard to how sponsoring institutions educate for professionalism, monitor behavior on the part of residents and faculty and respond to issues concerning; (i) accurate reporting of program information; (ii) integrity in fulfilling educational and professional responsibilities; and (iii) veracity in scholarly pursuits.

Executive Summary

Thank you to everyone for making our very first CLER visit a smooth and successful one We know the visit required continuous accommodations in scheduling that were rapidly accepted, and we greatly appreciated it. Everyone was positive, actively participating and demonstrating the professionalism we expect. Our site visitors were able to have candid conversations with all participants in the group meetings and on the visits around the medical center. They were able to gather a great deal of information about the clinical learning environment that we all support. We received initial feedback from the site visitors that was informative.

It was a very positive experience. The ACGME surveyors Drs. Bixby & Casey met with hospital and GME leadership, as well as program directors, faculty and residents. They also visited several locations in the hospital; Family Med, Oto clinics and received input from more than 20 nursing, ancillary and hospital staff. At the end of the visit they shared their observations with the leadership; which was all very constructive and informative. We will receive a formal report within 30-60 days. We're looking forward to a continue improvement in all of the CLER areas and we'll continue to partner with Crittenton Hospital on improvement with the 6 CLER focus areas using the recent published CLER pathways as an inspirational guide. Meeting Three will focus on Transition in Care, Supervision and writing and publishing scholarly work, half-day workshop on Friday morning. Developing an Effective Resident Quality Council: **Keys to Success. Since the inception of the AGME's Clinical** Learning Environment Review (CLER) two years ago, there has been an increased focus on the integration of graduate medical education and quality improvement. Early findings from CLER site visits indicate that programs with robust Resident Quality Councils are well-poised to meet the demands of providing an optimal learning environment. Such concepts are nothing new for the Alliance of Independent Academic Medical Centers (AIAMC). Many of our members have created and implemented resident quality councils (RQCs) and have great stories to tell.

Resident Quality Council Update

916/14—the RQC convened at UPG headquarters. President Ziad Kanaan MD, PhD from IM and VP Ike Onyedika from Ortho Surgery led the meeting. The RQC will meet on the Tuesday before the GMEC meeting to address resident concerns that span the institution with GME support. The agenda included a discussion on research support for a workshop at Crittenton for FM, TY, and IM residents. GME was eager to investigate this and provided contact information to existing interest groups fro each specialty. RQC members expressed interest in establishing more visibility for GME residency programs with medical students on the main campus. RQC members discussed meal privileges for each program in accordance to accreditation requirements. Several programs were interested in training materials for EndNote and Qualtrics, which were provided by GME.
